#### 4.0 President's Address – Dannielle Lunsted

These days, I'm tired, and I'm burnt out, and I'm emotionally drained by how unbalanced the world feels today.

I went through the previous presidential addresses for inspiration, and the common theme through all of them is twofold. Every year we comment on how difficult our profession is, and the conditions and adversity we need to work through. And this year is no different, we think the pandemic is over and the fallout just keeps going, and then comes flu season, short staffing and mandated overtime, and union negotiations and politics.

But the second theme is the perseverance and passion that our profession has. And once again, this year is no different. Despite whatever comes our way, we press on, and we show up, and we serve our communities. For that, we should all be very proud. I want all of you to know that I see you, and we see each other. In order to continue the important work we do, we need an influx of dedicated

volunteers to not only keep MAMLS going, but to thrive and do more to serve the members of our profession across Manitoba. We need to get out there and recruit more young people to find their way to the lab, and we need to serve those of us already in the profession with more CE, more access to funds, and more support. Although this group is doing their very best, and I'm more than grateful for all the dedication I've seen this year from the MAMLS board, we still need more help. I sincerely urge you to consider volunteering with us. The positions we have open for 2024 include Vice President and Professional Development. If you can't commit to a position, but you do have the time to volunteer in some capacity, please reach out to the presidential email address which you can find on our website, so we can let you know how you can help, whether it be attending a recruitment event, or volunteering to present for a CE event. Please follow our social media pages for other ways you can volunteer. It would really really be a shame if we have to disband MAMLS because I know, as a group, we are so passionate about our profession. And although we're all really struggling right now to find the energy, if you find some, please pick MAMLS.

So, for me, I'm going to switch from regular coffee to espresso, and keep on keeping on, because our patients need us, and MAMLS needs us, and we need each other.

9.0 Report from the Board of Directors – Dmytro Yamchuk The year 2022 was a very exciting year for MAMLS and for all laboratory professionals. It was a year of great events where once again our community could gather and celebrate the lab profession.

## This Year:

MAMLS welcomed the new Board members: Dannielle Lunsted (Caruk) as Vice President, Shona Litke as the Marketing and Communications Director, and Anita Koleva as Executive Assistant. As well as returning members: Sarah Crawford for a second term as MLA Representative, and Llora Alejandro-Yarema was appointed as Recording Secretary.

LABCON 2022 was held in Winnipeg, and it was a great success. After being canceled in 2020, it brought an amazing opportunity for the lab community to reconnect and celebrate the lab profession. Many of our members were able to attend with the support of the Hilda Fleming Fund. I want to thank CSMLS and all the volunteers for organizing this event. I was fortunate to attend and honored to be representing MAMLS along with other Board members. Many wonderful topics were presented, and I encourage all our members to attend LABCON in the future.

MAMLS participated as judges for Manitoba Schools Science Symposium and helped promote lab professions.

The Finance committee continued to transition our records into QuickBooks under direction of the Auditors. A special thank you to our Treasurer, Melanie Couture for spearheading this project.

Highlights of 2022:

• Due to the pandemic, MAMLS was unable to hold our AGM in 2020. We held an additional AGM in March of 2022 to catch up to present time. It was a virtual event using the Zoom platform, and we included 2 CE sessions for our members. Members also voted on important changes to

our By-laws, allowing the association to be more inclusive, and to better reflect its needs.

- Select MAMLS board members received additional training from Verda Design, to better maintain and improve our website.
- On the 5th of November, MAMLS held its second AGM, at Canad Inns Club Regent, Winnipeg, an in-person and virtual event. It also included 2 CE sessions for our members.
- MAMLS met with CMLTM's team and representatives of the Office of the Health Minister to discuss future MLA regulations as well as to advocate for all lab professionals. The board voted in favor of officially supporting the future regulation of MLAs in Manitoba.
- MAMLS was able to support Spring Fling hosted by Capitol Academy in April. Many members attended and were able to enjoy continuing education sessions.
- I was able to represent MAMLS as president, and attend CSMLS's Council on Government and Public Relations, where we discussed issues facing the industry on a national level. The topic of MLA regulation was especially noted. MAMLS is excited about the possibility of Manitoba being the first province to regulate MLAs.

I would like to thank all of the passionate and dedicated Board members for their efforts and support during my time as President. I am looking forward to mentoring the new Board and am excited to see how their new ideas take shape for promoting the Medical Laboratory Profession in 2023.
